Re: APSA Insurance Cover 15/16
- Full Member coaches
- Junior Member coaches (Level 0)

APSA has secured an insurance policy which meets our needs as coaches. It is a Sports Cover Australia Policy underwritten by Lloyd's.

All coaches who are current financial members of an APSA affiliated State member are insured under the three following categories (subject to policy limitations and exclusions) whilst coaching within the parameters of their level of accreditation. Junior members (Level 0 coaches) should note the specific parameters below that have been provided to the insurer. Any claim against the insurance policy will be required to be signed off by APSA prior to being assessed by Sports Cover Australia.

- Public Liability - Up to \$20,000,000 in any one claim and in the aggregate;
- Products Liability – Up to \$20,000,000 in any one claim; and
- Professional Indemnity - Up to \$5,000,000 in any one claim and in the aggregate
- Management Liability - Office bearers and committee members of APSA Inc. and all Affiliated Associations.

All coaches should adhere to the following recommendations:

1. Coaches are reminded to minimize the risk of accident and injury to themselves and others, by following the guidelines advised in your accreditation course.
2. Coaches involved in any incident during their coaching should keep detailed records including at least the date, venue, witnesses and an account of the incident.

3. Coaches are reminded to seek out their own comprehensive travel insurance whilst coaching overseas or attending competitions as they are not covered for coaching activities overseas.
4. Loss of income protection is minimal under the accident and injury policy. Coaches are recommended to take out their own income protection insurance as per their individual needs.
5. Coaches using either fixed overhead or mobile pole harness apparatus must maintain a current competency assessment with APSA.

Junior members (Level 0 Coaches) must adhere to the following extra parameters that APSA has disclosed to the insurer:

1. Junior members (Level 0 coaches) will only be covered whilst coaching skating school classes for their ice rink's learn to skate program.
2. Junior members (Level 0 coaches) coaching private group classes such as synchronized teams or private ice hire groups will not be covered under APSA's policy.
3. Junior members (Level 0 coaches) will be covered whilst standing in with APSA approved trainer coaches to complete their 40 hours of apprentice coaching for Level 1 accreditation.
4. Junior members (Level 0 coaches) pay a reduced fee for insurance due to their limited capacity to be able to coach.
